Four geological boreholes are planned on Portions 606, 882, 972, and 1392 (indicated as BH1 to BH4 on the Map).

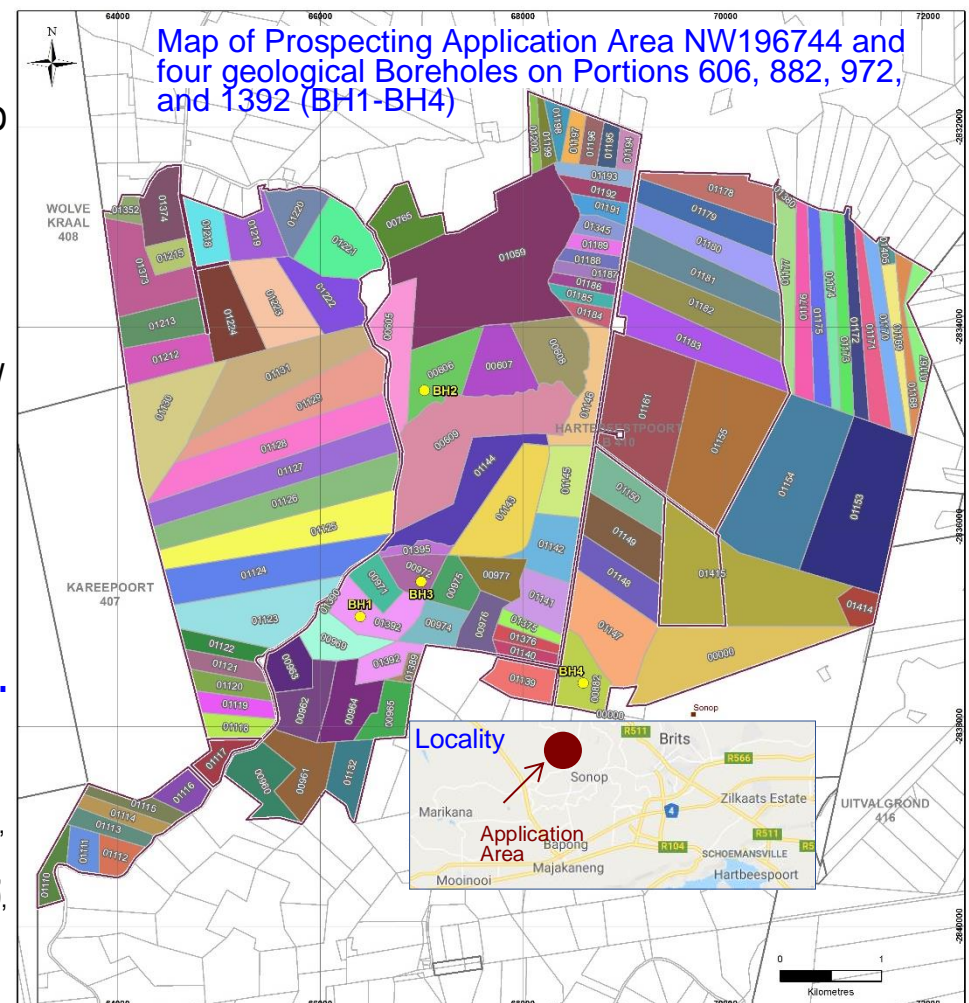
